## "4-step Anti-Acne" Treatment

Cosmetic procedure "4-step Anti-Acne" is a complete and very effective program that will allow to keep Acne -problems of customers under control. With the help of the "4-step" program, your clients will note a sharp reduction in acne, acne, redness and a decrease in the fat content of the skin. It will close the pores, remove the acne-spots (post-acne) and give the skin a healthy appearance, make it clean and smooth. LOGOR Cosmetics has developed a series of products designed specifically for clients with Acne problems. Our unique combination of ingredients make the procedures from our Company very effective in treating even the most difficult cases. Thanks to the introduction of newly developed active ingredients such as Ak.net™, Acnacidol BG™, Laricil™, Oligopeptide10 along with well-known Anti-acne ingredients such as Salicylic acid, Camphor, Organic Sulfur, Colloidal Silver and in combination with such natural ingredients, like Propolis, Citric Acid, Natural Extracts and Vitamins - in the complex, make the "4-step" procedure one of the most advanced in the market.

This salon treatment of Acne problems in combination with a line of products for caring for problem skin at home will help beauticians get excellent results in treatment and maintenance of the results achieved, offering the client a line of products for home care.

### Step 1. **Severe Acne problem.**

The treatment is intended for clients with severe Acne. This is one of the most difficult forms of Acne for treatment.

**Problem:** the face completely covers acne and acne, visible redness, acne, mostly with white heads. If the Acne condition of the clients is not this form, apply "**STEP 2**" (see below).

**Attainment:** to minimize the breakthroughs of acne, to clear the skin of acne and acne, to remove redness.

#### **Procedure:**

1. Prepare the skin by thoroughly cleansing the face using **Blemish Control Cleanser**.
2. Cover your eyes with cotton balls, thus protecting against ingestion of the ingredients used. Apply **Pre-Steam Gel** (layer 1 - 2 mm) and leave for 10-12 minutes.
3. Using cotton pads and a soft dry towel, gently remove the gel from the face, starting from the left side of the face, from top to bottom, in the direction from the forehead to the chin, trying to extract the pimples with the white head as much as possible. Then apply to this part of the face **Blemish Control Toner**. In case of bleeding, instead of tonic, use a 3% solution of hydrogen peroxide. Repeat the same procedure for the other side of the face.
4. Apply Acne Mask and leave for 10-12 minutes.
5. Remove the mask with a warm, damp towel.
6. Wadded disc wipe face with **Blemish Control Toner**.
7. Using a cotton pad or a soft dry towel, wipe the skin dry and apply **Blemish Control Powder**.
8. To process the face with the help of the High Frequency Current device within 3-4 minutes.

9. Surplus the powders with a cotton swab, place bleeding and the appearance of sucres, treat **Blemish Cure**, using a cotton swab. This procedure is repeated several times, usually every 7-10 days, until the condition of the facial skin is stabilized.

### Step 2.

**A typical problem is Acne.**

This procedure is intended for clients with mild or moderate Acne or as a continuation of treatment after the successful completion of "Step 1".

**Problem:** for this type of acne, the following are visually observed: the face partially covers acne in combination with acne, increased skin fatness, but there is no pronounced redness on the skin.

**Attainment:** to clear the skin of acne and acne, reduce fat and moisturize the skin.

**Procedure:**

1. Prepare the skin by thoroughly cleansing the face using **Blemish Control Cleanser**.
2. Apply **Massage Gel** and massage the face for 10 minutes.
3. Wipe the faceplate with a cotton disc using **Blemish Control Toner**.
4. Cover your eyes with cotton-wool discs, thus protecting against ingestion of the ingredients used. Apply **Pre- Steam Gel** (1-2 mm layer) and leave for 10-12 minutes. Perform a thorough removal of acne and acne.
5. Wipe the face with **Blemish Control Toner**.
6. Apply **Anti Acne Serum**, followed by facial treatment with an Ultrasonic Device for 10 minutes.
7. Apply **Blemish Control Mask** (1-2 mm layer) and leave for 10 minutes.
8. Remove the mask with a warm, damp towel.
9. Wipe the face with **Blemish Control Toner**.
10. Using a cotton pad or a soft dry towel, wipe the skin dry and apply **Blemish Control Powder**.
11. Bring the face treatment with the help of the High Frequency Current device for 3-4 minutes.
12. Using a cotton swab, apply **Blemish Cure** to the acne and acne extraction sites for disinfection. This procedure should be applied until the disappearance of pimples and acne.

For home care (STEP 2), the following products are recommended:

**Step 3.**  
**Post - Acne recovery.**

This treatment procedure is designed to normalize the structure and appearance of the skin. In case the client's skin is sensitive to glycolic acid, go to "**Step 4**".

**Problem:** at this stage, the client has acne-spots, acne scars, skin color irregularity and a small amount of acne.

**Attainment:** to remove the remnants of acne - spots, reduce fat content and moisturize the skin, eliminate acne scars and improve the complexion.

**Procedure:**

1. Prepare the skin by thoroughly cleansing the face using **Marine Scrub** or **Coral Scrub**.
2. Cleanse your face with a warm, damp towel.
3. Apply **Massage Gel** and massage the face for 10 minutes.
4. Wadded disc wipe face with **Blemish Control Toner**.
5. Cover your eyes with a cotton pad to protect and apply 20% or 30% **Glycolic Peel** and leave for 10 minutes. Carefully follow the reaction on the skin, following the instructions of the procedure "Glycolic".
6. Rinse thoroughly with warm water. Make sure the **Glycolic Peel** is completely removed. If not completely removed, wash your face again until the glycolide pilling is completely removed.
7. Apply **Pre-Steam Gel** (1-2 mm layer) and leave for 10-12 minutes.
8. Clear out the face from acne.
9. Wipe the face with **Blemish Control Toner**.
10. Apply **Blemish Control Mask** (1-2 mm layer) and leave for 10 minutes.
11. Remove the mask with a warm, damp towel.
12. Wipe the face with **Blemish Control Toner**.
13. Bring the face treatment with the help of the High Frequency Current device for 3-4 minutes.
14. Apply Anti Acne Serum.

For home care (STEP 3), the following products are recommended:

**Step 4.**  
**Post-acne stabilization.**

This treatment is intended to continue the restoration of the structure of the skin and is an alternative to the procedure for treatment with glycolic acid. At this step, acne - the problem should be under control.

**Problem:** usually at this stage, clients have acne-spots (post-acne), acne scars and acne scars, heterogeneity of skin tone in a residual, insignificant form.

**Attainment:** to get rid of acne spots, reduce fat content and moisturize the skin, eliminate

acne scars and improve the complexion.

**Procedure:**

1. Prepare the skin by thoroughly cleansing the face using **Blemish Control Cleanser**.
2. Apply **Massage Gel** and massage the face for 10 minutes.
3. Wipe the face with **Blemish Control Toner**.
4. Cover your eyes with cotton-wool discs, thus protecting before the subsequent procedure. Apply **Pre- Steam Gel** (1-2 mm layer) and leave for 10-12 minutes.
5. Carry out a thorough cleansing of the face from acne.
6. Wadded disc wipe face with **Blemish Control Toner**.
7. Apply **Blemish Control Mask**, following the instructions on the label, to perform light massage of the problem area of the face and leave for 10-12 minutes.
8. Remove the remains of the mask with a warm, damp towel.
9. Wipe the face with **Blemish Control Toner**.
10. Using a cotton pad or a soft dry towel, wipe the skin dry and apply **Blemish Control Powder**.
11. Bring the face treatment with the help of the High Frequency Current device for 3-4 minutes.
12. If necessary, treat the place of extraction of blackheads with **Blemish Cure**, using a cotton swab.

You can choose between the "step 3" and "step 4" procedures to ensure the desired effect for the customer. At this stage, the need for home care should be emphasized.
